

## Boggs Township Board of Supervisors

Regular Meeting  
February 1, 2022

The February 1, 2022 regular meeting of the Boggs Township Board of Supervisors was held in the Boggs Township Municipal Building, 1270 Runville Road, Bellefonte, PA. Meeting called to order at 7:00 pm. The Pledge of Allegiance was observed. Present were Supervisors David Veneziano, Terry Gates, Glenn Coakley, Zoning Officer/UCC Administrator Jeffrey L. Williams, and Solicitor Rodney Beard.

### Public Comment:

1. Corey Bowmaster (Milesburg Citizen's Hook & Ladder Fire Company) and Beau Martin (Snow Shoe Fire Company) talked about making Snow Shoe Fire Company first due on Hall Road box numbers in Boggs Township. Snow Shoe Fire Company is approximately 9 miles closer than Milesburg Fire Company. Corey and Beau will contact Norm Spackman at Centre County Emergency Communications get his prospective on the change. According to Corey and Beau, the camps in this area could possibly get a reduction in fire insurance costs with Snow Shoe Fire Company being the Primary response Fire Company. No actions needed by the supervisors at this time.
2. Mike Matis - asked about raising the sewer manhole that is on the curve by the Ertley Property. David Veneziano will speak to Mid-Centre County Authority about this manhole. C & R Directional Drilling will be re-surfacing the road at this location in the spring of 2022. Mike was also concerned about ice/slush on Curtin Hollow Road near Ed Nyman's. David Veneziano will look into the road conditions.
3. Vicky Catherman, Ralph Catherman and Mary Glunt from Antis Run Road - Asked about the status of the Clean-up at the Carol Packer Property. Jeff Williams responded that some progress is being made, but then more stuff shows up. Jeff will continue to monitor the progress and he has allowed a time extension due to winter weather conditions.
