

Boggs Township Board of Supervisors

Regular Meeting

July 5, 2022

The July 5, 2022 regular meeting of the Boggs Township Board of Supervisors was held in the Boggs Township Municipal Building, 1270 Runville Road, Bellefonte, PA. Meeting called to order at 7:00 pm. The Pledge of Allegiance was observed. Present were Supervisors David Veneziano, Terry Gates, Glenn Coakley, Zoning Officer/UCC Administrator Jeffrey L. Williams, and Solicitor Rodney Beard.

Public Comment:

1. Patty Mauk 263 Swampoodle Road wanted to know the progress of Jeff Richner's Junkyard clean-up. Progress is slow.
Motion by Gates 2nd by Coakley to start the formal process of enforcing the ordinance to get the cleanup moving faster.

2. Mike Miller 241 Swampoodle Road stated there is a pothole on Bomboy Road that needs filled. Mike will have a surveyor place 2 Witness Pins at the corner of his property. Township not getting involved with setting pins.
3. Alyshia Dann Sunset Acres checking on status of the codification, specifically the ordinance pertaining to raising chickens in residential zone. Solicitor Beard apologized for not getting this revision done in a timely manner.
4. Ralph and Vicki Catherman and Mary Glunt questioned the progress of the cleanup of the Packer property. A hearing is scheduled for August 3, 2022. Cannon is being discharged on a regular basis. Solicitor Beard explained that township does not have an ordinance to address the noise from the cannon. Tarps have been put up for screening.
5. Commander Lynn from Rockview Barracks gave some statistics regard the State Police calls in Boggs Township. Total calls for January to June 2022 was 600, down slightly from last year.
6. Bob Bennett 226 Peace Road asked about Reading or Hard Copies of the Supervisor Meeting Minutes for the public - will look at options to improve communication.

Solicitor - Rodney Beard reported he is working on amendments for ordinances for the codification. Completed Agency Open Records Officer form to change the officer. Suggested for the Township to contact our Auditor regarding the change of the treasurer. Motion by Gates 2nd by Coakley to contact the Auditor about the change of the treasurer.
