

## **Boggs Township Board of Supervisors**

Regular Meeting  
September 6, 2022

The September 6, 2022 regular meeting of the Boggs Township Board of Supervisors was held in the Boggs Township Municipal Building, 1270 Runville Road, Bellefonte, PA. Meeting called to order at 7:00 pm. The Pledge of Allegiance was observed. Present were Supervisors David Veneziano, Terry Gates, and Zoning Officer/UCC Administrator Jeffrey L. Williams.

### **Public Comment:**

1. Patti Mauk at 263 Swampoodle Road wanted to know if the township was going to budget money for Spongy Moth spraying in the 2023 Township Budget. Supervisors advised her to check the Centre County Government website for information on the Spongy Moth spraying. Also, the supervisors will consider budgeting money for Spongy Moth spraying.
2. James Stem at 1451 Runville Road reported that water is continuing to pool on Runville Rd near his driveway. Supervisors will check with PennDot about getting the water into the ditch. Supervisors will talk to Centre County Conservation District regarding water run-off.
3. Jared Packer at 125 Curtin Hollow Road left the supervisors know that he has 2 dumpsters for cleaning up and that his mother and neighbor had a disagree. Carol Packer left the supervisors know the ditch between her property and Todd Irv's property is not functioning properly. She said the Trump truck at the End of Curtin Hollow Road is causing a site distance issue when pulling out of Curtin Hollow Road. Supervisors will look into this issue. She would like to know what types of garbage can be burned. The township secretary will provide her with the Centre County Solid Waste Authority's phone number so she can contact the Authority for more information.


