# **Boggs Township Board of Supervisors**

Regular Meeting October 4, 2022

The October 4, 2022 regular meeting of the Boggs Township Board of Supervisors was held in the Boggs Township Municipal Building, 1270 Runville Road, Bellefonte, PA. Meeting called to order at 7:00 pm. The Pledge of Allegiance was observed. Present were Supervisors David Veneziano, Terry Gates, Glenn Coakley, Solicitor Rodney Beard, and Zoning Officer/UCC Administrator Jeffrey L. Williams.

### **Public Comment:**

- James Stem at 1451 Runville Road asked if anything has been done about his water issue. Supervisor Veneziano has forwarded Mr. Stem's contact information to the Centre County Conservation District. Chris Myers will contact Mr. Stem about a site visit.
- Sue and Leroy Warner at 741 Market Street received a zoning violation for installing a fence. They explained that they are replacing an existing fence. Solicitor Beard could not find a zoning ordinance requiring a zoning permit to replace a fence. No permit will be needed.
- 3. Mike Miller asked about pot holes on Bomboy Rd. The road crew will repair the area before the asphalt plants close in November.
- 4. Mike and Paula Furl questioned the water issue raised by James Stem. They believe there is not water from their property causing Mr. Stem's water issue. The water is natural run-off and underground springs. They will communicate with Mr. Stem outside the township meeting.
- 5. Mary Glunt thanked the township for repairing the road on Antis Run Road.
- 6. Ralph and Vicki Catherman asked about the status of the Carol Packer hearing. Solicitor Beard explained that the District Magistrate fined Mrs. Packer. Also, the township is working toward zoning compliance.

He reported that the Boggs Township will need to adopt a resolution based on ACT 57 of 2022 directing the tax collector on excess charges related to late payments. This resolution needs to be adopted by the end of 2022. Mr. Beard informed the supervisors that he needs to advertise that the Annual Financial Audit will be completed by a CPA firm.
