

## **Boggs Township Board of Supervisors**

Regular Meeting

August 1, 2023

The August 1, 2023 regular meeting of the Boggs Township Board of Supervisors was held in the Boggs Township Municipal Building, 1270 Runville Road, Bellefonte, PA. Meeting called to order at 7:00 pm. The Pledge of Allegiance was observed. Present were Supervisors David Veneziano, Terry Gates, Glenn Coakley, Solicitor Rodney Beard, and Zoning Officer/UCC Administrator Jeffrey L. Williams.

### **Public Comment:**

1. Ron Fisher – 612 Circle Road – asked supervisor about reducing speed limit on Circle Road. Supervisors explained that to reduce the speed there is a process that needs to be followed, but the township does not have any means to enforce the speed limits. The supervisors will investigate other ways to calm traffic on Circle Road.
